PASTORAL COUNCIL MINUTES OCTOBER 6, 2015

Robin opened the meeting. Lauren read the Gospel for the Twenty-eighth Sunday in Ordinary Time. Linda read the reflection. The Gospel from Mark dealt with the young man who questioned Jesus about what he had to do to enter the Kingdom of God. Ultimately, when Jesus told the man he must give away all he owned and follow Him, then young man walked away disappointed because he had much wealth. Jesus then told his disciples, "How hard it is for those who have wealth to enter the Kingdom of God." The reflection spoke of using wealth wisely and giving credit where credit is due—to God. (Sunday Prayer for Catholics 2015, LTP)

Rich pointed out that in the day, those who were wealthy were thought to have found favor with God. For Jesus to say that it would be harder for the rich to gain entry into Heaven suggested that entry was impossible for everyone. Robin mentioned that the beginning of the Gospel for Sunday that talked about the wealthy young man was skipped in our booklet. But the part that touched her was that Jesus looked upon the young man with love, because He knew what was in his heart.

VOCATIONS AWARENESS WEEKEND—October 31/November 1

Robin will focus her column in the bulletin on vocations and will ask Deacon if he could do the same with his. Cindy read some suggestions from the Diocese website. One was to "adopt a seminarian". We talked about having a drive for items to send to our seminarians in a "care package". We could start the drive on Vocation weekend and continue through the next weekend Masses. The other suggested activity was to have our parish youth send letters to the seminarians. This would include our school, PSR, and youth groups.

YEAR OF MERCY—Begins December 8th

What will we do as a parish--i.e. Sacrament of Penance, Divine Mercy Chaplet, or Parish Mission? Welcome back Catholics to the church?

Robin distributed a list of the Corporal Works and the Spiritual Works of Mercy each with examples of ways to carry them out. More can be found on USCCB website and in the *Bull of Indiction of the Extraordinary Jubilee of Mercy* which can be found on the Vatican website.

Robin thought it might be too soon to have another parish mission. Besides, the prime time to hold a mission would be in January, and there just isn't enough time to get one together. We talked about focusing on a different Work each month—perhaps include a speaker series.

We all agreed that the idea of opening the Year of Mercy with praying the Divine Mercy Chaplet with adoration on Saturday at 3 p.m. and follow it with reconciliation. Perhaps we could provide this devotion at least once a month—possibly on the first Saturday of the month—during this dedicated year.

Father asked that we, as a Pastoral Council, **try** to attend at least one session. The attendance at the first session was pretty disappointing. There were only about 16 people there. UPDATES ON SECURITY PLAN

Robin reported that Sgt. Gunderson came and walked around the campus. He will write up a list of recommendations. He did suggest we perform a security check in the mornings when the buildings are opened. He also suggested that we lock the Vandalia Street doors between the 12:15 and 5:15 Masses. He said there are security training programs available. We discussed having our ushers, greeters and sacristans as well as office and school personnel go through this training.

PASTORAL ASSOCIATE REPORT

Robin reported that Theology Uncorked has a good group attending. They are considering a session on the Corporal Works and Spiritual Works of Mercy. Frequent Flyers Group (Young Adult Ministry) has an event planned at Father Jeff's house on October 24th.

Tom Ohren still needs more people to help with the Visitation Ministry. There was a suggestion to put a dedicated flyer in the bulletin asking for help. Cindy said that this weekend the Stewardship Council is having their Service witness talks. There will be a flyer in the bulletin listing all the service ministries available at St. B.

OTHER BUSINESS

Rich mentioned his concern for maintaining the solemnity of Consecration during Mass on Wednesday nights. The choir begins its warm up in the main church around 7 p.m.—right around the same time as the Consecration at the 6:45 Mass.
